1.0 INTRODUCTION AND BACKGROUND

As required by Louisiana Children's Code, Article 1217.1 and 1239.1, the Department of Children and Family Services (DCFS) is submitting this report to the public in accordance with the law.

ACT 6 amended and reenacted Children's Code Articles 1213(A) and (B), 1233, and 1235 and enacted Children's Code Articles 1213(D), 1217.1, and 1239.1, relative to adoptions; to provide for post-placement functions for agency and private adoptions; to provide for visits prior to finalization; to provide for assistance to the families and children; to provide for reporting and statistical requirements; to provide relative to a final decree of private adoption; and to provide for related matters.

2.0 OVERVIEW OF DATA AND DEMOGRAPHICS

The Louisiana Department of Children and Family Services implemented policies and procedures in 2021 related to Act 6. In accordance with Children's Code Art. 1217.1 and 1239.1- Reporting requirement; statistical availability

For each adopted child, the court shall ensure that the department receives all of the following information: (1) Whether either of the adopted parents are related to the child. (2) The age of the child at placement. (3) The age of the child at the time of finalization. (4) The gender of the child (5) The race of the child (6) The location of placement (7) Other non-identifying information the department requests in order to maintain statistical records of adoption finalizations.

The department shall release yearly statistics on adoptions and placements of children in Louisiana. These statistics shall be made available to the public.
